Grand High Priest's Message

Companions,

I never expected to be doing a second July article for the Workman, except maybe as a guest. We all have to realize Covid-19 has disrupted our lives in ways that will last a generation. In our small membership (under 5000) we have had very few actual cases of the virus reported. I believe we have had two deaths reported and Excellent Companion Paul Erickson, who was hospitalized with the virus, has recovered back to his regular activities. We are praying that those low numbers remain in our membership.

Although there has been difficulty of continuing our normal routine of business and the succession of Grand Chapter, we have planned for a virtual Annual Convocation to take place on July 15, 2020. Our Companions and Sir Knights will have finished both of their virtual sessions by then and we hope to have learned from their efforts on procedures to be successful at our session.

We are planning on actually presenting the legislation as was planned in the case of a normal Convocation. Voting will take place by two methods. First by "poll vote" which is fast and not weighted beyond one vote per delegate and second by an electronic voting method which is weighted by the number of ballots each delegate is entitled to as in a regular session. Please vote for the good of the order.

As I informed you earlier in the year we (the executive committee) had some hard decisions to make concerning our future. We carefully followed the guidance of our constitution and good

financial practices to make changes in our method of operation. We managed to do it with unanimous agreement to follow this plan through the next five years to keep us in good financial shape. For the first time in several years the full per capita collected in January is available for R. E. Bullard to use in his budget starting on July 1. He will however be constrained, because we have not raised our per capita enough in past years to actually pay as we go, instead of dipping into savings each year and depleting our reserves. When R. E. Broomfield presents his resolution to raise the per capita this year, when passed, it will not be seen until his year. This will allow the GHP for the first time, to make an actual budget that is based on the real funds available, instead of a guess that in the end requires a use of reserves.

We changed the fiscal year from March 1 - February 28 to July 1 - June 30, which means the budgeted funds actually are used in the Capitular year of the new administration. Thank you, for all the advice and support we received from members in this effort. Our Jurisprudence Committee worked overtime confirming our actions and advising on the constitution, including actions that were not addressed directly in the constitution.

I want to thank publicly several people who have made my year memorable and enjoyable. First and foremost my wife of almost 54 years, who has helped me in so many ways. Although she was crowned Grand Royal Matron of California Order of the Amaranth in February 2019, she still made time to support me in every way possible. I tried to reciprocate as much as possible but I am sure she did much more than I. She started way back in 2015 by sewing gifts for M. E. C. Steve Goad and continues right up to today, currently making needed covid-19 masks. She is a jewel beyond compare.

M. E. C. Steve Goad, my "Capitular father," did more than appoint me to the progressive line. Through the years he has advised me on many of the actions I needed to address. He kept me out of the quicksand that can drown you slowly, just because you stepped wrong. M. E. C. Teddy Hammack really started me with appointments and actual work in the Grand Chapter beyond that of Inspector. M. E. C. Phil Hardiman our Grand Secretary advised me even before taking on his current job. We don't always agree, but his advice is always invaluable.

I thank the progressive line, particularly R. E. C. Bullard, Grand King and R. E. C. Broomfield, Grand Scribe. They provided help from the beginning as we all have progressed. All of my major actions were in truth, the action of us three. I truly appreciate the support I received from the Chapters and members across the state, this cannot be overstated. Of all the help, this was most critical to a successful Capitular year for your Grand Chapter. There are so many others that I should name but time and space limit me. Thank you to all and please continue to support the new GHP as he is elected this month.

Be well and continue to grow our membership.

As you know by now, the Grand Officers and Trustees voted to cancel Grand Sessions scheduled for July 14-16 at the Wyndham in Visalia. The Grand Council has already hosted a virtual Grand Assembly on June 20th, using the Zoom platform; Grand Commandery will do the same on July 11th at 10:00 am. Given the Grand Master's recent restrictions (July 1st) on Masonic gatherings "of any kind," the Grand High Priest has decided to cancel the combination Virtual and face-to-face gathering that was to be held in Sacramento on July 15th. The Annual Convocation for Grand Chapter will now be virtual only. If you booked a room at the Sheraton, expecting to come to Sacramento, you need to cancel the reservation now.

If you would like to attend the Virtual Grand Convocation on July 15th, you must register so we have a head-count for the meeting. If you want to ballot on matters to be presented, you also must register and provide your email address. You can also get a copy of the AD form there, as there is still time to submit one for your organization. And there is information allowing you to learn about the virtual platform.



SECRETARY and/or RECORDER ESSENTIALS

Forms and Documents you will need are located at the Grand York Rite website, which is: www.yorkriteofcalifornia.org.

Scroll down and click on "York Rite Forms and Documents." Then click on the appropriate logo. A window opens where you enter the userid, which is "cagyr" and the password, which is "brio"

Scroll down to Officers Manual, which has information for the Secretary, and print that out. Many concepts in the Grand Chapter manual are relevant to the Councils and Commanderies.

Priorities are as follows:

1. **Dues Collection** – You should send out dues notices no later than October, with payments from members due by December 31st.
2. **Membership control** -- Especially important is the very last item, "Royal Arch Monthly Report." This is relevant to you as a Secretary/Recorder if you do not yet have a userid for access to MMS – Masonic Membership Solutions. If you fill the paper report out each month, whenever you encounter changes to the membership, you will find it much easier at the end of the year to produce the year-end report, which is used to compute the amount of per capita the Chapter needs to pay. That payment is due by Jan 15th each year. Important changes to your membership include new members, demits, remits and deaths. Maintain e-mail addresses for members and you can easily then forward the monthly newsletter, The WORKMAN, to them.
3. Do not cavalierly suspend members for non-payment of dues. There is a Constitutional process that should be followed rigorously in order that members, who may have moved and not received your dues notice, are treated fairly. See the following sections of the relevant Constitution in order to learn about this process:

4. **Per Capita** -- The Per Capita payment, due each Jan 15th, does not require action by the Chapter to be paid. You will need good, up-to-date end-of-year number of active members that is crucial for us when we compute your per capita payment. Without good data you will most likely overpay your per capita requirement. It is sensible to begin your process near the end of the CY, as soon as possible. It is also sensible, if you have access to the Grand Lodge database, to check each member to see if they are still alive. But most important is getting a userid to utilize MMS.
5. **Insurance** -- The Insurance payment, due each July 15th, does not require action by the Chapter, Council or Commandery to be paid. You will be billed for the payment by the Grand Secretary-Recorder.
6. **Lodge Book of Marks** – Maintain this up-to-date, or perhaps arrange for a PHP to take on the responsibility of maintaining.
7. **Minutes** – Take good minutes, but don't over-do it by trying to capture everything that is said. Focus on having a clear representation of motions made and the vote count by which they passed or failed. In addition to keeping petitions in a separate file, it is good practice to replicate the basic petitioner information in the minutes. It is also a good practice to keep the names of attendees at each meeting in the minutes. If conferring a degree, keep a copy of the cast members and the candidate(s). Also, please send the candidate class names to the Grand Secretary.
8. **Grand Sessions** – Before the April meeting, remind the Dais officers they are responsible to attend, and arrange a stipend if your Chapter, Council or Commandery can afford it. Remind members who expect to attend to be sure to take their dues cards. If Dais Officers of the Chapter and Council cannot attend, they may issue a proxy, or they may elect a representative. This is true also for Commanderies, whose members cannot issue proxies. The appropriate forms can be obtained on the Grand York Rite website: Scroll to "Elected Representative and Proxy Credentials."
9. **Order of High Priesthood** – Be sure the current HP and PHPs know they are eligible to receive this Order. In fact, it is a Constitutional requirement! Share the petition with them and send to the Grand Secretary. This requirement does not appear to be true for the Thrice Illustrious Master Degree or the Past Commander's Association. Petitions for all three bodies are available at the secure website.
